Restricted and Prohibited Items







Carried items that pose a risk to safety and security are restricted and forbidden; therefore, we included a list of items below to help you decide what is allowed to carry and what is restricted.

Liquids and Food

Liquids or comparable items of similar consistency (such as gels, aerosols, lotions, creams, and toothpaste) may only be carried by travelers in small quantities and in small containers.

The maximum size of a container is limited to 100 ml. The containers must be placed and transported in a clear plastic, zip lock bag having a maximum volume of 1 liter. The bag may contain several containers but it must still be possible to completely close the bag. Only one bag is permitted per passenger. This bag must be removed from the carry-on baggage and presented to security personnel at the checkpoint for separate X-raying.

You are allowed to carry as much liquid medicine and does not need to be inserted in transparent plastic bags but should have them ready for inspection by airport authorities.

Medical Devices and Medications

Medications and special dietary requirement, are permitted in carry-on baggage if needed on board. These must be removed from the carry-on baggage and declared to security personnel at the checkpoint.

Electrical Items/Battery Driven Wheelchair

Power driven wheelchairs shall only be accepted as checked baggage provided that the battery is disconnected, and the battery terminals are insulated to prevent accidental short circuits (e.g. by being enclosed within a battery container) and the battery is securely attached to the wheelchair. Electrical items can be permitted inside your hand baggage or your checked baggage while some items are banned and restricted.

Sporting equipment

General sporting equipment is allowed in checked baggage at an extra cost depending on the type and restrictions.

Bicycle must not exceed 23kg of carried to Europe and 32kg to other destinations.

Musical instruments can be taken on board providing they fit within the maximum bag dimensions in cabin overhead.

Musical instruments which are too large to be carried in cabin will be hold checked in.

Sharp, and bladed tools which can cause injuries are strictly not allowed to carry in hand baggage such as knives, scissors, blades, bats and screwdrivers etc.

Tools and Sharp Objects

Passengers are not permitted to carry the following articles into security restricted areas and on board an aircraft:

- items designed for chopping, such as axes, hatchets and cleavers,
- ice axes and ice picks,
- razor blades,
- box cutters,
- knives with blades of more than 6 cm,
- scissors with blades of more than 6 cm as measured from the fulcrum,
- martial arts equipment with a sharp point or sharp edge,
- swords and sabres;

Workmen's tools — tools capable of being used either to cause serious injury or to threaten the safety of aircraft, including:

- crowbars,
- drills and drill bits, including cordless portable power drills,
- tools with a blade or a shaft of more than 6 cm capable of use as a weapon, such as screwdrivers and chisels,
- saws, including cordless portable power saws,
- blowtorches,
- bolt guns and nail guns;

Blunt instruments — objects capable of being used to cause serious injury when used to hit, including:

- baseball and softball bats,
- clubs and batons, such as billy clubs, blackjacks and night sticks,
- Martial arts equipment

Flammable/Chemical Items

Flammable, corrosive and chemical items including acids which may cause damage to the aircraft or other load are strictly prohibited on board the aircraft.

Carriage of Firearms and Ammunition

Firearms may conditionally be accepted on MEA Flights and it is subject to approval provided they are carried as checked (hold baggage). Firearms must be for sporting purposes, disassembled and not be accessible to passengers during flight.

The carriage of firearms and ammunitions is subject to any restrictive condition(s) applicable in countries of departure, transit, transfer or destination. For more information, please contact as at +9611629999.

passengers are not permitted to carry the following articles into security restricted areas and on board an aircraft:

Guns, firearms and other devices that discharge projectiles — devices capable, or appearing capable, of being used to cause serious injury by discharging a projectile, including:

- firearms of all types, such as pistols, revolvers, rifles, shotguns,
- toy guns, replicas and imitation firearms capable of being mistaken for real weapons, component parts of firearms, excluding telescopic sights,
- compressed air and CO 2 guns, such as pistols, pellet guns, rifles and ball bearing guns,
- signal flare pistols and starter pistols,
- bows, cross bows and arrows,


— harpoon guns and spear guns,
— slingshots and catapults;
Stunning devices — devices designed specifically to stun or immobilise, including:
— devices for shocking, such as stun guns, tasers and stun batons,
— animal stunners and animal killers,
— Disabling and incapacitating chemicals, gases and sprays, such as mace, pepper sprays, capsicum sprays, tear gas, acid sprays and animal repellent sprays.
explosives and incendiary substances and devices — explosives and incendiary substances and devices capable, or appearing capable, of being used to cause serious injury or to pose a threat to the safety of aircraft, including:
 ammunition, blasting caps, detonators and fuses, replica or imitation explosive devices, mines, grenades and other explosive military stores, fireworks and other pyrotechnics, smoke-generating canisters and smoke-generating cartridges, dynamite, gunpowder and plastic explosives.

Dangerous Goods

Dangerous goods must not be carried in or as passengers or crew, checked or carry-on baggage, except as otherwise provided below. Dangerous goods permitted in carry-on baggage are also permitted "on one's person", except where specified otherwise.




